

ORDINANCE NO. 6365

AN ORDINANCE AMENDING HOT SPRINGS MEMORIAL FIELD ZONING ORDINANCE NO. 3524 BY ADOPTING THE 2020 GARVER PART 77 SURFACES MAP; DECLARING AN EMERGENCY; AND FOR OTHER PURPOSES.

*WHEREAS*, Hot Springs Code, Chapter 1, Article II *Airport Zoning*, known as “Memorial Field Zoning Ordinance,” was adopted September 10, 1979 (Ordinance No. 3524); and

*WHEREAS*, Hot Springs Code, Sec. 11-1-15, creates and establishes certain zones which include all of the land laying beneath the approach surfaces, transitional surfaces, horizontal surfaces, and conical surfaces as they apply to Memorial Field; and

*WHEREAS*, Hot Springs Code, Sec. 11-1-15, refers to a map prepared to demonstrate those specified surfaces; and

*WHEREAS*, it is now desirable to update that map and data contained within it.

***NOW, THEREFORE, BE IT ORDAINED*** by the Board of Directors of the City of Hot Springs, Arkansas, as follows:

**SECTION 1. Memorial Field Zoning Amendment.** That Ordinance No. 3524 is hereby amended by replacing the Hot Springs Memorial Field Airport Airspace Drawing Plan View and Airspace Drawing Extended Plan View Maps as prepared by Barnard Dunkelberg & Company and dated February 2001 with the herein approved and attached Part 77 Surfaces Map (Exhibit A) as prepared by Garver dated December, 2020.

**SECTION 2. Emergency.** It is hereby found and determined that an emergency exists; and this ordinance, being immediately necessary for the protection of the public health, safety and welfare, shall be in full force and effect from and after the date of its passage and approval.
